PRIVACY STATEMENT

NB: This statement only applies to individuals.

- We collect personal details to identify and contact you. We also collect information relating to your financial position and credit status to decide whether to deal with you.
- We collect information directly from you, or through a broker or other intermediary. We may also collect information in the public domain, such as from searches of property ownership or electoral rolls. We may also with your consent obtain a credit report from a third party.
